## Update from the Chief

As we transition into fall, West Mason Fire is excited to say that we are moving into a new phase of the year. Now we are finally able to focus on training and making sure that the volunteers have the things that they need.

We have 4 people attending the Mason County Fire Academy. This academy is graciously paid for by the State Fire Marshal's Office. Soon, we will start ramping up for the winter EMT class for those who wish to become Emergency Medical Technicians. To keep our credentials, both volunteer and career staff alike, are required to continuing education to maintain their provider certifications.

We are preparing for the Washington State Survey and Ratings Bureau. This entity determines how we rate in the eyes of the fire insurance industry. West Mason Fire will renew its tender credit for the areas that do not have fire hydrants. With the successful completion of the tender credit, the areas with no hydrants will only drop one class instead of all the way to the bottom of the scale. When we are finished with the evaluation, we will publish our new ratings on our website.

Now for the big news! We have responded to several fire calls with the new engine. This has allowed our volunteers and career staff to be more efficient and effective. All of the firefighters truly appreciate the support and the ability to get away from some very old equipment.
